The Entrance Examination was held on $\underline{09^{th}}$ June, $\underline{2018}$ for admission IN Bachelor of Optometry, B.Sc. (H) Medical Technology in Radiography, Dental operating Room Assistant, Dental Hygine of AIIMS, New Delhi and (OTAT), (MLT), (MTIT) seats of AIIMS Bhubaneswar for $\underline{\text{August, 2018}}$ session at AIIMS. The Result was declared on dated $\underline{18^{th}}$ June 2018. As per result, your roll number and rank in the merit list are given in the letter/AIIMS website (www.aiimsexams.org).

The 1st counselling for allocation of seats for admission to i) Bachelor of Optometry ii) B.Sc. (H) Medical Technology in Radiography, iii) Dental operating Room Assistant, iv) Dental Hygine v) Operation Theatre Technology of AIIMS, New Delhi, and for AIIMS Bhubneswar seats vi) Operation Theatre & Anaesthesiology Technology (OTAT), vii Medical Laboratory Technology (MLT) viii) Medical Technology in Imaging & Therapy (MTIT) for the session August, 2018. Ist counseling will be held on Tuesday the 10th July, 2018 at 9:00 a.m. sharp* You are, therefore, requested to report to the Academic Section AIIMS New Delhi on the above mentioned date and time along with your roll number, rank letter and original certificates. In case you are selected for admission on the basis of first counselling, you are required to appear for medical examination to be held on 25th July, 2018 at 9.00 A.M.* Those candidates who fail to report for 1st counselling will not be considered for 2nd counselling.

The 2nd counselling will be held on Tuesday, the 19th July, 2018 at 9:00 a.m. subject to the availability of seats for August, 2018 session. You are, therefore, requested to kindly report to the Academic Section for 2nd counselling on Tuesday, the 19th July, 2018 at 9:00 a.m. sharp*. The selected candidates during the second counselling will be medically examined on 24st July, 2018 at 9:00 a.m. sharp*. In case the selected candidate on the basis of 1st and 2nd counselling do not report for medical examination the offer made to them will be treated as cancelled/withdrawn.

The selected candidates, after they are found medically fit, are required to join immediately and no extension for joining will be entertained.

Those candidates who have been allotted confirmed seats in the 1st counselling will not be eligible/ considered for 2nd counselling.

In each category the number of candidates called for counselling will be 8 times the number of seats. The order of counselling will be all categories. The candidates in order of merit will exercise their choice of subjects/course according to availability of seats in their respective category.

Out of the total seats (excluding AIIMS reserved seats) 27% seats are reserved for OBC candidate, 15% of seats are reserved for the Scheduled Caste candidates, 7.5% seats are reserved for Scheduled Tribe and 5% seats are reserved for OPH candidates. In case suitable candidates belonging to Scheduled Caste and Scheduled Tribe categories are not available, the vacant seats will be filled in by the candidates from the general category.

In case any candidate is unable to appear in person on the notified date(s) for personal appearance, he/she can send his/her authorized representative with an **undertaking and authority letter for allotment** (proforma of undertaking and authority letter is given at Appendix ii and iii) along with original certificates/documents mentioned above for verification. **The allotment made to the authorized representative shall be binding on the candidate**. However, the candidates are required to join immediately after medical examination.

<u>Please note that if the candidate/person authorized by the candidate reports without original documents he/she will not be allowed to participate in the counseling procedure for allotment of seat.</u>
