**Revised Medical/Non-Medical Qualification Category Inclusion of Subject in the  
Department of Lab Oncology Code No.107 (b) for Ph.D. Programme, January 2017 session**

As per the directions received from Academic Section, AIIMS, following changes in the Registration form as well as modifications/clarification in Prospectus are being made. The details are as follows. Accordingly, following may be read as modified/clarified eligibility.

2.	<b><u>Medical Qualification:</u></b> MBBS/BDS with minimum 55% aggregate marks or MD/MS/MDS/DM/M.Ch in the subject concerned or Diplome of National Board of Examination candidates who have obtained any of these degrees from medical colleges which are not recognized by the Medical Council of India shall not be eligible to apply. <b><u>Nursing Qualification:</u></b> Candidates holding M.Sc. degree with minimum 55% aggregate marks in Nursing specialty will also be eligible for Ph.D admission in College of Nursing. <b><u>Non-Medical:</u></b> For nonmedical candidates eligibility shall be Master's Degree  (two years course) awarded by Indian Universities or equivalent in the subject as per requirement of the project. Candidate possessing Master Degree through distant learning course shall not be eligible.	Other eligibility/qualifications will remain same and accordingly, it is clarified that candidates holding M.Sc. (other than M.Sc. Nursing), M.Tech. degree & BAMS will be eligible for the Non-Medical Qualification Category.

Those candidates who have applied in BAMS & M.Sc. subjects (other than M.Sc. Nursing) under **Medical Qualification Category** will now be considered in **Non-Medical Qualification Category**.

In the Student Interest, the last date of Registration process will be to **21.01.2017 (05:00 PM)** instead of **19.01.2017 (05:00 PM)**.

Accordingly, those candidates who have already completed the Registration process and fulfilling the eligibility under Non-Medical Qualification Category are advised to submit their copy of qualifying the National Entrance Test (in the year 2015 or 2016, refer Prospectus Page No. 27) through Registered Email on ***exams.ac@gmail.com latest by 21.01.2017 (upto 05:00 PM)***.

All other contents available in the Prospectus will remain unchanged.
